

How to Participate in the 2024 Merit-based Incentive Payment System (MIPS) Using a Centers for Medicare & Medicaid Services (CMS)-Approved Qualified Clinical Data Registry (QCDR) or Qualified Registry

This is an informational guide to support clinicians, groups, virtual groups, subgroups, Medicare Shared Savings Program Accountable Care Organizations (ACOs), and/or Alternative Payment Model (APM) Entities with the selection of a QCDR and Qualified Registry and participation in MIPS using a QCDR and Qualified Registry.

Third party intermediaries are entities that CMS has approved to submit data on behalf of a MIPS eligible clinician, group, virtual group, subgroup, Shared Savings Program ACO, or APM Entity for one or more of the quality, improvement activity, and/or Promoting Interoperability performance categories.¹ They don't directly support the cost performance category as CMS collects and calculates the data for the cost performance category. Third party intermediaries may support MIPS eligible clinicians that participate as individual clinicians, groups, virtual groups, subgroups, Shared Savings Program ACOs, and/or APM Entities, inclusive of voluntary and opt-in reporting.

Third party intermediaries are intended to decrease burden on MIPS eligible clinicians. They include QCDRs, Qualified Registries, health information technology (IT) vendors, and CMS-approved survey vendors. **Please note that this guide will focus on QCDRs and Qualified Registries only.**

What is a QCDR?

A QCDR is defined as an intermediary that demonstrates clinical expertise in medicine and quality measurement development and collects medical or clinical data on behalf of a MIPS eligible clinician to track patients and diseases to foster improvement in the quality of care provided to patients.²

A QCDR may include:

- An intermediary with clinical expertise in medicine. Clinicians must be on staff with the organization and lend their clinical expertise in the work carried out by the organization as a QCDR.
- An intermediary with stand-alone quality measurement development experience.
- An intermediary that collects medical or clinical data on behalf of a clinician for the purpose of patient and disease tracking to foster improvement in the quality of care provided to patients.
- An intermediary that uses an external organization for purposes of data collection, calculation, or transmission may meet the definition of a QCDR as long as the intermediary:
 - Has a signed, written agreement that specifically details the relationship, roles, and responsibilities of the intermediary with the external organization effective as of September 1 the year prior to the year for which the intermediary seeks to become a QCDR.

What is a Qualified Registry?

A Qualified Registry is a data intermediary that collects MIPS data from MIPS eligible clinicians and submits it to CMS on their behalf. Clinicians typically work directly with their chosen Qualified Registry to submit data on the selected measures or activities they have selected.

Should I select a QCDR or Qualified Registry as my third party intermediary?

Both QCDRs and Qualified Registries are able to collect and submit data to CMS on behalf of MIPS eligible clinicians. Unlike Qualified Registries, QCDRs have the opportunity to develop and support up to 30 CMS-approved QCDR measures. The QCDR measures are an additional set of quality measures available only for reporting through a QCDR. The QCDR measures may include specialty specific measures or disease process measures that aren't available within the MIPS quality measures inventory.

How do I select a QCDR or Qualified Registry?

Every year, CMS publishes a list of CMS-approved QCDRs and Qualified Registries that self-nominated to participate as a QCDR and Qualified Registry for the MIPS performance period. The [2024 QCDR Qualified Posting \(XLSX, 195 KB\)](#) and the [2024 Qualified Registry Qualified Posting \(XLSX, 200 KB\)](#) are available on the [Quality Payment Program \(QPP\) Resource Library](#).

The 2024 QCDR Qualified Posting and Qualified Registry Qualified Posting are lists of all intermediaries that are authorized by CMS to submit quality measures, improvement activities, Promoting Interoperability measures & objectives, and/or MIPS Value Pathways (MVPs) on behalf of the individual clinician, group, virtual group, subgroup, Shared Savings Program ACO, and/or APM Entity for purposes of the 2024 MIPS performance period. These intermediaries are approved as QCDRs and/or Qualified Registries by CMS through the [MIPS Self-Nomination Toolkit for QCDRs and Registries \(ZIP, 12.7 MB\)](#) process. CMS hasn't otherwise evaluated the capabilities, quality, or any other features of any specific intermediary or its products referenced on the 2024 QCDR Qualified Posting or 2024 Qualified Registry Qualified Posting. Reference to any specific intermediary, commercial product, process, or service (collectively, "specific intermediary or its products") doesn't constitute any endorsement or recommendation of the specific intermediary or its products by CMS or the United States Government. Such reference doesn't imply that a specific intermediary or its products meets any other federal health care program requirements applicable to the intermediary, its products, or to the individual clinician, group, virtual group, subgroup, Shared Savings Program ACO, and/or APM Entity on whose behalf the intermediary submits data to CMS. Prior to selecting or using any specific entity or its products, the individual clinician, group, virtual group, subgroup, Shared Savings Program ACO, and/or APM Entity should perform their own due diligence on the intermediary and its products (that may include contacting the intermediary directly to learn more about its products).

Getting Started with the 2024 QCDR Qualified Posting or 2024 Qualified Registry Qualified Posting

The 2024 QCDR and/or Qualified Registry Qualified Posting resources contain a significant amount of information useful in selecting a QCDR or Qualified Registry for the 2024 MIPS performance period.

Version History Tab

The qualified postings contain a Version History tab (example below) that lists updates within the qualified postings made after the initial publication. If updates are available, the QCDR and/or Qualified Registry Qualified Posting resources will be updated on a monthly basis throughout the year. These updates may include QCDR or Qualified Registry status updates, as intermediaries may:

- withdraw,

- be subject to remedial action, and/or
- be terminated throughout the MIPS performance period.

Table of Contents Tab

The qualified postings contain a Table of Contents (TOC) that includes a hyperlinked list of QCDRs and Qualified Registries approved as third party intermediaries for the 2024 MIPS performance period, as well as information regarding which performance categories (quality, improvement activity, Promoting Interoperability) are supported by the QCDR or Qualified Registry. This tab also contains information regarding which QCDRs and Qualified Registries are supporting MVPs. MIPS eligible clinicians should identify QCDRs or Qualified Registries that support the applicable reporting options, participation options and performance categories needed for reporting.

The remaining tabs of the qualified postings contain detailed information specific to each QCDR or Qualified Registry. Each QCDR and Qualified Registry provides the information included within the qualified posting and provides approval of accuracy prior to CMS publishing the 2024 QCDR Qualified Posting or 2024 Qualified Registry Qualified Posting. Selecting a QCDR or Qualified Registry using the 2024 QCDR Qualified Posting or 2024 Qualified Registry Qualified Posting

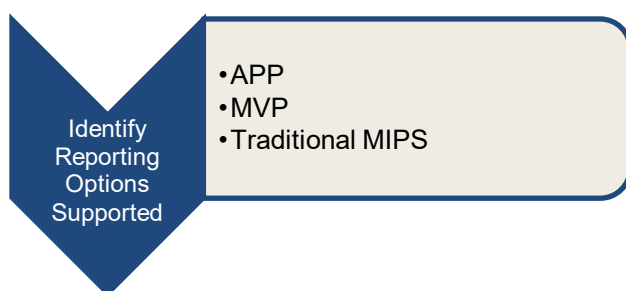
MIPS eligible clinicians should use the following steps to identify QCDRs or Qualified Registries that may be able to fill their reporting needs. It may be beneficial to identify more than one applicable QCDR and/or Qualified Registry and research the options to identify the best possible QCDR and/or Qualified Registry for you.



Step 1. Select a QCDR or Qualified Registry will suit your reporting needs.

Both QCDRs and Qualified Registries are able to collect and submit MIPS data to CMS on behalf of MIPS eligible clinicians. Unlike Qualified Registries, QCDRs have the opportunity to develop and support up to 30 CMS-approved QCDR measures. The QCDR measures are an additional set of quality measures available only for reporting through a QCDR. The QCDR measures may include specialty-specific measures or disease process measures that aren't available within the MIPS quality measures inventory.

Step 2. Identify a QCDR(s) and/or Qualified Registry(ies) that offers the applicable reporting option(s) needed.



Select a QCDR(s) and/or Qualified Registry(ies) that support the reporting options that meet your reporting needs. For the 2024 MIPS performance period, QCDRs and Qualified Registries are required to support MVPs that are applicable to the MVP participant on whose behalf they submit MIPS data. QCDRs and Qualified Registries may also support the APP and Traditional MIPS.³

Step 3. Identify a QCDR(s) and/or Qualified Registry(ies) that offers the applicable performance categories needed.

Identify Performance Categories Supported

- Quality
- Improvement Activities
- Promoting Interoperability

Identify a QCDR(s) and/or Qualified Registry(ies) that support the performance categories that meet your reporting needs. For the 2024 MIPS performance period, QCDRs and Qualified Registries are required to support the quality, improvement activities and Promoting Interoperability performance categories; however, some QCDRs and/or Qualified Registries qualify for an exception and don't support all categories. A third party

intermediary may be excepted from the requirement to support the Promoting Interoperability performance category if all supported MIPS eligible clinicians fall under the reweighting policies. In instances where some of the participants don't fall under the reweighting policies described above, the QCDR or Qualified Registry will be expected to comply with the requirements.

Step 4. Identify a QCDR(s) and/or Qualified Registry(ies) that offers the applicable participation option(s) needed.

Identify Participation Options Supported

- Individual Clinician
- Group
- Virtual Group
- APM Entity
- ACO

Identify a QCDR(s) and/or Qualified Registry(ies) that support the participation options for which you're planning to participate in the MIPS program.

Step 5. Identify a QCDR(s) and/or Qualified Registry(ies) that offers the applicable activities and measures needed.

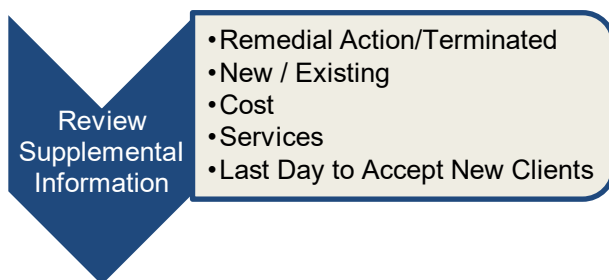

Identify a QCDR(s) and/or Qualified Registry(ies) that support the improvement activities, Promoting Interoperability measures, MIPS CQMs, MIPS eCQMs, QCDR measures and/or MVPs for which you're planning to submit data to CMS for purposes of MIPS. Step 6. Review the supplemental information to evaluate the QCDR(s) and/or Qualified Registry(ies) to identify the ideal candidate.



Review the accompanying information, regarding remedial action/termination, new/existing participation, cost, services and/or last day to accept new clients to identify the ideal candidate for your reporting needs. You may also wish to research the QCDR(s) and/or Qualified Registry(ies) on your own or contact them directly for more information.

Step 7. Contact the QCDR(s) and/or Qualified Registry(ies).



Contact the QCDR(s) and/or Qualified Registry(ies) to begin contract discussions and/or commit to a specific QCDR and/or Qualified Registry. At this phase you'll work with your QCDR or Qualified Registry to begin participating with the third party intermediary.

What to expect when participating with a QCDR or Qualified Registry?

QCDRs and Qualified Registries must meet certain requirements to be approved and included in the qualified posting. These requirements are detailed further within the [2024 Self-Nomination Toolkit for QCDRs and Qualified Registries \(ZIP, 12.7 MB\)](#) available on the [QPP Resource Library](#). MIPS eligible clinicians participating with a QCDR or Qualified Registry should familiarize themselves with these requirements, especially with those listed below as they're requirements that involve their clinician, group, virtual group, subgroup, Shared Savings Program ACO, and/or APM Entity clients.

Business Associate Agreements

QCDRs and Qualified Registries must enter into and maintain with its participating MIPS eligible clinicians an appropriate business associate agreement that provides for the QCDR or Qualified



Registry's receipt of patient-specific data from a MIPS eligible clinician, as well as the QCDR or Qualified Registry's disclosure of quality measure results and numerator and denominator data or patient specific data on Medicare and non-Medicare beneficiaries. Business associate agreements must meet the requirements of any applicable laws and regulations, as well as comply with the Health Insurance Portability and Accountability Act (HIPAA) Privacy and Security Rules. MIPS eligible clinicians should work with their QCDR or Qualified Registry to ensure this legal contract is finalized according to the nature of their relationship with the QCDR or Qualified Registry.⁴

Clinician Consents

QCDRs and Qualified Registries must obtain, and keep on file, signed documentation that each holder of a National Provider Identifier (NPI) (whose data are submitted to the QCDRs and Qualified Registries) has authorized the QCDR or Qualified Registry to submit quality measure results, improvement activity results, Promoting Interoperability results and numerator and denominator data or patient-specific data on Medicare and non-Medicare beneficiaries to CMS for the purpose of MIPS participation. This consent must meet the requirements of any applicable laws, regulations, and contractual business associate agreements. Individual clinicians participating in MIPS via a QCDR or Qualified Registry must grant permission to the QCDR or Qualified Registry to submit their data to CMS. Groups, virtual groups, subgroups, Shared Savings Program ACOs, and/or APM Entities participating in MIPS via a QCDR or Qualified Registry may have their group's duly authorized representative grant permission to the QCDR or Qualified Registry to submit their data to CMS. MIPS eligible clinicians should work with their QCDR or Qualified Registry to ensure proper consent is given to the QCDR and/or Qualified Registry.⁵

Feedback Reports

QCDRs and Qualified Registries are required to provide timely feedback, at least 4 times a year, on all of the MIPS performance categories that the QCDR or Qualified Registry will report to CMS for purposes of MIPS. This provides specific feedback regarding how the clinician, group, virtual group, subgroup, Shared Savings Program ACO, and/or APM Entity compares to others who have submitted data on a given measure or activity within the QCDR or Qualified Registry. The feedback should be given to the clinician, group, virtual group, subgroup, Shared Savings Program ACO, and/or APM Entity at the participant level for which the QCDR or Qualified Registry reports. The QCDR or Qualified Registry is only required to provide feedback based on the clinician's, group's, virtual group's, subgroup's, Shared Savings Program ACO's, and/or APM Entity's data that's available at the time the performance feedback is generated. An available dashboard that provides real-time feedback throughout the 2024 MIPS performance period will suffice as meeting this feedback requirement. If a real-time feedback dashboard is available to clinicians, CMS asks that the QCDR or Qualified Registry email MIPS eligible clinicians at least 4 times a year, to remind them the feedback is available.⁶
